From the North:

- Follow Interstate 95 South to Exit 9, Route 4 South
- Follow Route 4 South to Route 1 South
- Stay on Route 1 South for approximately three miles
- At major intersection (Tower Hill) take right onto 138 West for approximately five miles (pass URI on right)
- Great Swamp Field Headquarters sign comes up on the left, follow road all the way until you must take a left onto dirt road; follow until you enter the area of the Headquarters building then see signs for range.

From the South:

- Follow Interstate 95 North to Exit 3, Route 138 East
- Follow Route 138 East approximately 10 miles
- Great Swamp Management Area sign on right; follow road all the way until you must take a left onto dirt road; follow until you enter the area of the Headquarters building then see signs for range.
